## NOTICE OF ACCEPTANCE OF COMPLETION OLYMPIC VALLEY FUEL REDUCTION OV-1 PROJECT

**SUBJECT:** Filing of Notice of Acceptance of Completion

**BACKGROUND:** Fuel Reduction Projects are not defined by legislation as “Public Works” projects, and as such, there is no requirement to register the project with the Department of Industrial Relations (DIR) or to file a notice of completion. While it is not legally required, it is best practice to file a notice of completion and record the notice with the Placer County Recorder’s Office. Filing a notice of completion initiates the time frame for subcontractors and suppliers to file a lien if they have not been paid.

**DISCUSSION:** Cross Check Services completed work on the OV-1 project in July, successfully reducing hazardous fuel loading across a total of 120 acres in accordance with the project’s prescription. All equipment, trucks, and materials have been removed, and the Contractor has demobilized from the site. Permanent erosion control measures and BMPs have been installed as governed by CAL FIRE Exemption 14 CCR 1038.
