

Total Incident Amount



Dear OVPSD Board of Directors,

On Saturday, August 24th, Olympic Valley FD was dispatched with Truckee FPD to the report of a two-vehicle head-on collision on Hwy 89, approximately .5 miles south of West River Street.

Truckee Fire arrived and confirmed the conditions and location. There were five occupants, all of whom were altered or unresponsive and had sustained major traumatic injuries. Two were partial ejections, and all required extrication, one having legs severely pinned under the steering wheel and dashboard.

None of the resources initially on scene were equipped with the necessary auto-extrication tools. OVFD E21 and R21, equipped with state-of-the-art Holmatro extrication tools, arrived and were assigned to extrication. OVFD crews secured the vehicles, addressed hazards, triaged vehicles and patients, and went to work performing extrication.

In the end, all five patients, all with critical injuries, were extricated and transported - one to TFH and four to Renown.

OVFD crews performed admirably. Working effectively and efficiently in a race against the clock. While training on these scenarios played a very important role, the use of our new battery-operated extrication tools, which allow for significantly faster deployment and operating speeds and a greater cutting force than our previous equipment, allowed for a much quicker extrication and for the patients to reach definitive care faster and minimize life-threatening and/or lifelong injuries.

At the August 25, 2023, OVPSD Board meeting, I requested approval to purchase new auto extrication equipment, noting: "While Hurst was slightly less expensive, the advantages of Holmatro include faster opening/closing speeds, lighter, less maintenance intensive and an ergonomic design advantage making it safer and easier to use.

As evidenced above, this was not hyperbole. It was a genuine request that was met with your approval and made the difference in the lives of five people a few weeks ago, and will do so many times in the future.

OVFD would collectively like to say *Thank You* for providing us with these tools.
