## REFURBISHED SCBA CYLINDER PURCHASE

**DATE:** October 15, 2024

**TO:** District Board Members

**FROM:** Brad Chisholm, Fire Chief

**SUBJECT:** Fire Department Self-Contained Breathing Apparatus (SCBA) Purchase.

**BACKGROUND:** The Olympic Valley Fire Department's (OVFD) current complement of SCBA was purchased fifteen years ago using funding from an *Assistance to Firefighters Grant* (AFG) grant. In early 2024, OVFD and three other local fire agencies again applied for a regional AFG grant to replace our current SCBA. Unfortunately, we were unsuccessful in this bid, leaving 26 of our 32 SCBA cylinders needing to be replaced per Department of Transportation (DOT) mandate. However, the SCBA packs (vs. cylinders) still have a useful life and are budgeted to be replaced in 2029.

**DISCUSSION:** Staff has secured a quote from Dalmatian Fire Equipment for 26 refurbished, hydrostatically tested cylinders with valves, including tax and shipping, for \$13,520. The budget from fiscal year 2024 for the new replacement SCBA cylinders was \$55,000. This money was not spent in the prior fiscal year, however, it is still available for use from the reserve account. Rather than spend \$55,000 for new SCBA cylinders now, and replace the entire SCBA complement in 2029, including cylinders, staff propose purchasing refurbished cylinders to carry us over to 2029, or until we are awarded an AFG grant, whichever comes first. The Dalmatian quote is attached and is valid until October 27, 2024. The free shipping offer has been extended through October.

- ALTERNATIVES:**
1. Purchase 26 refurbished, hydrostatically tested cylinders with valves, including tax and shipping, for \$13,520 from Dalmatian Fire Equipment.
  2. Purchase 26 new SCBA cylinders with valves for approximately \$50,000.
  3. Delay the purchase and be in violation of DOT mandate.

**FISCAL/RESOURCE IMPACTS:** The quoted total cost to contract with Dalmatian is \$13,520. The replacement of these cylinders is necessary to comply with US DOT mandate. The funds will come from the Fire Department Fixed Asset Replacement Fund. As the cylinders were not identified in the FY2024-25 budget, a budget amendment in the amount of \$13,520 is required.

**RECOMMENDATION:** Approve the purchase of 26 refurbished, hydrostatically tested SCBA cylinders with valves from Dalmatian Fire Equipment in an amount not-to-exceed \$13,520, approve a budget amendment for an equal amount, and authorize the Fire Chief to execute contractual documents as needed.
