

## FUELS MANAGEMENT PROGRAM

- DISCUSSION: OV-3 Olympic Valley Road Fuel Reduction Project Update The OV-3 Project is a 3-acre hazardous fuel reduction project, primarily located on privately owned lands in Olympic Valley near the "S-Turn" on Olympic Valley Road. The Contractor expects the project to take approximately one week and be completed in November.

## OV-2/Additional OV-4 Phase Two Project Area

Registered Professional Forester Danielle Bradfield is evaluating a different approach that would look at the merits of combining OV-2 with the northern portion of the OV-4 Community Buffer Project (Phase 2). OV-2 is a large area adjacent to OV-1 (along the northern ridgeline); and OV-4. By combining OV-2 and OV-4, mechanical treatment may be feasible on a more significant portion of OV-4, potentially lowering costs and improving effectiveness. Bradfield plans to conduct a field evaluation this fall and prepare updated permit documents to make the area shovel-ready should future grant funding be awarded.

## Defensible Space Inspections (DSI):

With Placer County's November 30<sup>th</sup> deadline approaching for all short term rentals complete DSI, our crews and administration have been extremely busy accommodating the many last-minute requests. OVFD has successfully completed DSI inspections on 100% of residences in Olympic Valley – a notable achievement and unmatched by any other local Fre District. Even more remarkable is that our line firefighters perform this work. OVFD will continue to

enforce PRC 4291 (code that covers CA Defensible Space laws) and note Zone Zero deficiencies and Home Hardening opportunities.

**FISCAL/RESOURCE IMPACTS**: The District has been awarded almost \$1.4M in grant funding to plan and implement fuels management projects, as summarized below.

The District has an on-call contract with Danielle Bradfield, a Registered Professional Forester and Owner of Feather River Forestry, for grant writing and consulting services. This contract has a not-to-exceed amount of \$20,000 annually. Staff dedicate significant time to developing our Fuels Management Program and administering grant contracts.

Expenses related to the Green Waste Days (GWD) are funded through rates and the Garbage Fixed Asset Replacement Fund (FARF), which currently has a balance of approximately \$139,000. Estimated costs for this program include the Tahoe Truckee Sierra Disposal (TTSD) delivery, pick-up, and disposal of three 30cubic yard containers per GWD, along with administration and labor. These costs are expected to be approximately \$3,300 per event, assuming Friends of Olympic Valley (FoOV) and the Firewise Community can provide volunteers for the six District-sponsored GWDs.
