

## OPERATIONS DEPARTMENT ON-CALL TRUCK PURCHASE

**SUBJECT**: Purchase Operations Department On-Call Truck

**BACKGROUND:** The District maintains a fleet of vehicles for water and sewer operations,

including a Ford F-150 on-call truck. This truck, purchased in 2014, has reached its 10-year service life, with over 220,000 miles. It is starting to show signs of significant mechanical failures due to the excessive mileage on the vehicle. The on-call truck plays a critical role in enabling operations staff to respond to service calls and complete essential maintenance operations for the water and sewer

systems.

**DISCUSSION:** Staff worked with a qualified truck vendor utilizing the State's statewide contract

for fleet vehicles. As a special government district, we are eligible to procure vehicles at the state-contracted pricing. Downtown Ford Sacramento has provided a proposal for an F-150 regular cab, four-wheel drive truck that meets the specifications required by the operations department. Pending approval, the truck can be ordered immediately, with an estimated delivery timeline of five

The on-call truck is vital for ensuring prompt responses to water and sewer emergencies, including those that occur late at night and during severe weather conditions. Its reliability is paramount for serving the district's needs.

Additionally, staff recommends declaring the 1997 Ford Explorer surplus. Currently used by the engineering, administration, and operations departments for various tasks within the valley, its role will be assumed by the District's existing F-150 truck. The Explorer has served the District for 28 years, is experiencing mechanical issues, and has reached the end of its useful life. Staff plans to work with Ritchie Bros. or a similar outlet to try to auction the item.


- **ALTERNATIVES**: 1. Approve the purchase of an F-150 on-call truck for an amount not to exceed \$50,000, declare the existing Ford Explorer surplus equipment, and authorize staff to conduct a sale, donate and/or dispose of the item.
  - 2. Do not approve the purchase of an on-call truck. This alternative is not recommended as the existing F-150 on call truck is at the end of its operational service life.

FISCAL/RESOURCE IMPACTS: The project will be funded equally by the Water and Sewer FARFs. The FY24/25 budget includes \$50,000 for this purchase.

**RECOMMENDATIONS**: Staff recommends approval of the purchase of an F-150 in an amount not to exceed \$50,000, declaring the existing Ford Explorer surplus equipment, and authorizing staff to conduct a sale, donate, and/or dispose of the item.
