Fire Impact Fee Nexus Study:


In response to guidance from Placer County, the Fire Department Nexus Study has been revised to change the annual inflationary adjustment from an automatic process to one requiring action by the District Board and County, along with appropriate notice. Additional minor administrative updates have also been made. Staff plans to present the updated Nexus Study to the Board at a public hearing in March, including a request to rescind the resolution adopted in December 2024 and re-approve the Nexus Study, Capital Improvement Plan, and Fire Fee Program.


