

### **Capital Projects – Active**

## Sewer System Master Plan

- Work on the Master Plan is on-going.
- Consultant is focused on CCTV review and Capital Replacement Plan.
- Staff is focused on 100-yr CRP using VueWorks Budget Forecasting and developing future capital projects list and cost estimates.

# Administration Building HVAC Replacement Project

- The project went out to bid on April 10, 2025 with a bid opening date set for May 13, 2025.
- If bids are acceptable, staff will recommend award of construction contract at the May 27, 2025 Board meeting.
- Construction is scheduled for June-October 2025.

# Washeshu Creek Stream Gaging Improvement Project

- The District signed a grant agreement with DWR for \$208,000 in April 2025.
- A PSA was executed with UES (Dwight Smith) to plan, install, and maintain the stream gages over the course of the grant period ending March 31, 2027.
- Stream gages are expected to be installed by June 30, 2025.

- Roof replacement projects for District owned facilities at Well 5R, 1810
  Sand Barn, and 305 OV Rd.
- CASGEM groundwater monitoring
- Residential plan reviews and contractor/owner coordination for new and remodel construction
