

## **305 OLYMPIC VALLEY ROAD HVAC REPLACEMENT PROJECT**

- TO: District Board Members

- **SUBJECT**: 305 Olympic Valley Road HVAC Replacement Project Update
- BACKGROUND: The District solicited bids from eight (8) mechanical contractors to construct the boiler and controls system replacement project at the Fire Station & Administration Center. A non-mandatory prebid meeting was held on April 30, 2025 with five (5) contractors in attendance. Bids were opened on May 13, 2025. One bid was received from ACCO Engineering Systems, Inc. for the amount of \$2,321,415. The engineers' Opinion of Probable Cost (OPC) for the project at bid time was \$1,241,947. The District's Capital Budget includes \$1,300,000 set aside for the project construction.
- **DISCUSSION**: With the submission of only one (1) bid which far exceeds the OPS and the District's budget, the District will reject the single bid. Staff is currently working with our engineer, Ainsworth & Associates Mechanical Engineers (AA-ME), to develop a strategy to accomplish the project in a timely and cost effective manner.

AA-ME will be present at the May 27 Board meeting to discuss the project status, the OPC vs. the bid amount, and a proposed path forward.

ALTERNATIVES: This item is informational only.

**FISCAL/RESOURCE IMPACTS**: The project is budgeted as a capital replacement project funded equally through the Fire Department and Utility Department capital reserves. The total project budget is \$1,500,000, including \$1,300,000 for construction and \$200,000 consulting services for design, permitting, construction management, and 3<sup>rd</sup> party commissioning, construction, and District staff time.

**RECOMMENDATION**: This item is informational only.

## **ASSUMPTIONS and CLARIFICATIONS:**

- This proposal is based on the assumption that unobstructed access to the work areas will be provided to ACCO and its subcontractors.
- ACCO assumes that the existing system and its components to be re-used (HVAC, piping, electrical, roofing, ductwork, etc.) are in proper operating condition. ACCO cannot warrant the performance of existing equipment and systems.
- Startup of equipment is priced on a one time basis with consecutive days as necessary. Multiple startups at different intervals will be at an added cost. Early start-up during construction is not recommended and may void the warranty of the equipment.
- As the current US government administration continues its international trade negotiations and announce international trade tariffs, we are realizing rapid price fluctuations in raw materials, commodities and assembled components & equipment. As a result, our pricing can only be valid for <u>10 days</u>. If we see significant pricing fluctuations in the coming weeks, we will alert the project team and reserve the right to request remuneration. If funds can be made available to us for pre-purchase or to "lock-in" current prices we will work with our supplier community to support this effort and minimize price fluctuations.
- All work is to be completed during normal business hours (Monday through Friday from 7:00 am to 3:30 pm).
