RECOMMENDED ACTION: Adopt Resolution 2025-22 approving the Annual Report for the Fire Impact Fee Program and approve the annual inflationary adjustment to submit to Placer County for adoption by the Board of Supervisors.

DISCUSSION: Pursuant to the Mitigation Fee Act (AB 1600) codified in Government Code Section 66000 et seq., public agencies are required to adopt a development impact fee when there is a demonstrated reasonable relationship between the development project and the public services being funded. The Olympic Valley Public Services District ("District") has established fire impact mitigation fees for the Olympic Valley Fire Department.

Government Code Section 66006(b) requires the District to make an annual accounting of fees collected and expended in the fund within 180 days after the last day of each fiscal year.

The attached resolution acknowledges the Annual Report for Fiscal Year 2024-25. These reports provide an overview of the Fire Impact Fee Program, including an accounting of collected fees, expenditures, and any future improvements to be funded by the fees. No refunds or reallocations of fees are required at this time, and the District is in full compliance with the applicable sections of the Government Code.

The attached report and resolution also identify an annual inflationary adjustment needed in accordance with the 2024 Fire Impact Fee Nexus Study and the current Capital Improvement Plan for the Fire Department. The proposed fees will be effective 60 days after approval by the Placer County Board of Supervisors.

Approval of the resolution and subsequent adoption by the Placer County Board of Supervisors will ensure the District remains compliant with Government Code Sections 66006 regarding the Fire Impact Fee Program.

RESOLUTION 2025-23

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE OLYMPIC VALLEY PUBLIC SERVICE DISTRICT APPROVING THE FIRE IMPACT FEE PROGRAM ANNUAL FINDINGS REPORT, ADOPTING A CAPITAL IMPROVEMENT PLAN, AND REQUESTING THAT THE PLACER COUNTY BOARD OF SUPERVISORS ADOPT AND IMPLEMENT UPDATED FIRE IMPACT FEES ON BEHALF OF THE DISTRICT

- **WHEREAS**, the Olympic Valley Public Service District (District) is a public agency organized pursuant to California Water Code §30000, et seq; and
- **WHEREAS**, AB 1600 was passed and codified in California Government Code Section 66000 ("Mitigation Fee Act"), allowing the establishment of a development impact fee as a condition of approval where the purpose and use of the fees are identified, and a reasonable relationship to the development project can be demonstrated; and
- **WHEREAS**, the County of Placer ("County"), at the request of the Olympic Valley Public Services District ("District"), has established fire impact mitigation fees ("Reportable Fees') for the Olympic Valley Fire Department ("Department") within the District's boundaries; and
- **WHEREAS**, Government Code Sections 66001(d) and 66006(b) require the District to make an annual accounting of the Reportable Fees collected and expended and to make additional findings every five years if there are any funds remaining in the Reportable Fees fund at the end of the prior fiscal year; and
- WHEREAS, the District's Annual Findings Report for the Fire Impact Fee Program, FY 2024-25 ("Report") contains the requisite information and proposed findings concerning the collection and expenditure of Reportable Fees pursuant to Government Code Section 66006; and
- **WHEREAS**, the District's Reportable Fees are imposed pursuant to the Fire Impact Fee Nexus Study (March 2025) prepared by SCI Consulting Group ("Nexus Study"), which the District's Board approved via Resolution 2025-06; and
- **WHEREAS**, the Nexus Study's recommendations for the District's Fire Impact Fees include an annual inflationary adjustment to fund fire protection facilities, apparatus, and equipment necessary to mitigate the impacts caused by new development; and
- **WHEREAS**, the District's Board wishes to implement that inflationary adjustment for the coming year; and
- WHEREAS, the County of Placer ("County") Municipal Code § 15.36.010 provides that in any unincorporated area of the County where a local fire protection agency has adopted a capital improvement plan and identified a development fee in conformance with California Government Code Section 66000 et seq., and such fee is approved by the Board of Supervisors, payment of the fee shall be a condition of approval for any new development project within the area; and
- **WHEREAS**, the District intends hereby to update its capital improvement plan as relevant to its Reportable Fees; and

WHEREAS, the District Board finds that this Resolution, which implements the Fire Impact Fee program, does not constitute a "project" under the California Environmental Quality Act ("CEQA") as it merely provides a mechanism for funding necessary infrastructure without committing to any specific project that may cause a significant environmental impact (CEQA Guidelines § 15378).

NOW, THEREFORE, BE IT RESOLVED that the Board of Directors of the Olympic Valley Public Service District makes the following findings and takes the stated actions regarding the program as required by and in accordance with Government Code Section 66006(b):

- 1) The Board finds and determines that the foregoing recitals and determinations are correct.
- 2) Pursuant to Government Code Sections 66006(b)(1) and (2), the Board reviewed the Annual Report, which is incorporated by this reference and contains all of the information required by law
- 3) The five-year findings required by Government Code Section 66001(d) will be made at the same time as a future annual report required by Government Code Section 66006(b). However, no such five-year findings are required at this time.
- 4) The Board determines that the District is in compliance with Government Code Section 66000, et seq., regarding the receipt, deposit, investment, expenditure, and refund of Reportable Fees received and expended relative to improvements for Fiscal Year 2024-25.
- 5) The Board determines that no refunds and allocations of Reportable Fees, as required by Government Code Sections 66001(e) and 66006(b)(1)(H), are deemed payable at this time for Fiscal Year 2024-25.

FURTHER, IT IS HEREBY RESOLVED by the Board of Directors of the Olympic Valley Public Service District as follows:

- 1) The District Board hereby receives and approves the Fire Impact fee Schedule and the Department's capital improvement plan ("CIP").
- 2) Prior to the adoption of this Resolution, the Board conducted a public hearing at which oral and written presentations were made as part of the Board's regularly scheduled November 18, 2025 meeting. Notice of the time and place of the meeting, including a general explanation of the matter to be considered, has been published twice in a newspaper in accordance with Government Code Sections 66002 and 66018. Additionally, at least 14 days before the meeting, the District made available to the public, the CIP, data indicating the amount of the cost, or estimated cost, required to provide the service for which the fee or service charge is to be imposed pursuant to the Resolution by way of such public meeting, the District received the Mitigation Fee Report, attached as Exhibit A, which formed the basis for the actions taken pursuant to this Resolution.

3) After considering the Nexus Study, the Mitigation Fee Report and this Resolution, and after considering the testimony from the noticed public hearing as part of the District's regularly scheduled November 18, 2025 meeting, the District Board hereby approves the annual inflation adjustment for the Fire Impact Fee.

The following Fire Impact Fees on new development shall be collected upon the date of the final inspection or the issuance of the certificate of occupancy, whichever occurs first:

- 4) The District Board formally requests that the County Board of Supervisors implement this approved Fire Impact Fee program on behalf of the District, with the District agreeing to be responsible for the proper accounting for and expenditure of said moneys and further agreeing to hold the County harmless from and to defend it from any action, claim, or damages related to said fees, including any challenge to the validity of or use thereof.
- 5) If any portion of this Resolution is found by a court of competent jurisdiction to be invalid, such finding shall not affect the validity of the remaining portions of this Resolution.

ANNUAL REPORT: FIRE IMPACT FEE PROGRAM FY2024 - 2025

In accordance with Government Code Section 66006(b)(1) and (2), the Olympic Valley Public Services District ("District") provides the following information for the fiscal year 2024-25 for the Olympic Valley Fire Department ("Department") Fire Impact Fee Program.

BRIEF DESCRIPTION OF THE REPORTABLE FEE

The Department's fire impact fee ("Reportable Fee") will help maintain adequate service levels for fire protection in the Department. New development in the Department will increase the demand for fire protection services and associated facilities. The Reportable Fee will fund the construction of new or expanded fire facilities, apparatus, and equipment necessary to accommodate residential and nonresidential development in the District.

REPORTABLE FEE AMOUNTS

The District's Reportable Fees in effect at the end of fiscal year 2024-25 were \$500 per bedroom for residential and \$1.08 per square foot for commercial.

REPORTABLE FEE ACCOUNT BALANCES

The balance of the Reportable Fee account at the beginning of fiscal year 2024-25 was \$209,996. At the end of fiscal year 2024-25, the balance of the fund was \$100,468.

REPORTABLE FEES COLLECTED AND INTEREST EARNED

The amount of Reportable Fees collected during fiscal year 2024-25 was \$3,000. In addition, \$6,053 was earned in interest during the fiscal year. The total amount of Reportable Fees and interest collected during fiscal year 2024-25 was \$9,053.

USE OF REPORTABLE FEES

Reportable Fees in FY 2024-25 were expended on the Fire Impact Fee Nexus Study for \$34,623. There was also the purchase of a new utility vehicle and equipment for \$83,958. One hundred percent of the cost of these improvements was funded through fees.

IDENTIFICATION OF INCOMPLETE IMPROVEMENTS

As of FY 2024-25, there are no incomplete improvements.

INTERFUND TRANSFERS AND LOANS

There were no other interfund transfers or interfund loans from the Reportable Fee fund in fiscal year 2024-25.

REFUNDS

The District issued no refund of Reportable Fees in fiscal year 2024-25.

CAPITAL IMPROVEMENT PLAN

Development impact fees may be determined based on a Capital Improvement Plan ("CIP") or by the identification of facilities through broad classes, as permitted by Government Code Section 66001(a)(2). The District's 2025 Nexus Study identifies facilities by broad classes—land, stations, apparatus, and equipment. However, the District's 2025 Fire Department CIP was provided in Appendix D of the Nexus Study to give readers an indication of the specific future facilities, apparatus, and vehicles that may be funded by the District's fire impact fee.

As a condition of imposing the fee on the District's behalf, the County requires that the Department annually update its CIP, and that it be adopted by the District Board by resolution following the public notice and hearing procedures outlined in Government Code § 66002.

Below is the Department's Capital Improvement plan, as of October 2025.

FIRE IMPACT FEE SCHEDULE

An updated Fire Impact Fee Nexus Study was completed by SCI Consulting Group and approved by the Olympic Valley Public Service District Board of Directors in April, 2025 by adopting Resolution 2025-06. The study was further adopted by the Placer County Board of Supervisors in June 2025. The complete Study is available online at www.ovpsd.org or by calling (530) 583-4692.

The purpose of the Fire Impact Fees is to finance the public facilities and equipment as described. Fixed-rate pricing structures are unable to keep pace with changing costs of facilities, vehicles, and general fire protection infrastructure requirements. Thus, consistent with the spirit of the enabling legislation and as defined in the District's 2025 Nexus Study, the District proposes to adjust the mitigation fee schedule.

The adjustment is calculated using the Construction Cost Index (CCI) published by the Engineering News-Record for the San Francisco Bay Area. The CCI change for the period January 2024 through June 2025 was -1.57%. As such, fee adjustments are as follows:
