RECOMMENDED ACTION: Approve of Resolution 2026-01 authorizing execution of the Third Amendment to the Sewer Line Replacement and Dedication Agreement for the Granite Chief "A" Line Sewer Replacement Project.

DISCUSSION: In July 2024, the District entered into a Dedication Agreement (Agreement) with several property owners (Applicants) regarding the replacement of the Granite Chief "A" Line sewer. The Agreement outlines the terms and conditions under which the District will accept dedication of the new sewer assets and defines the rights and responsibilities of both the District and Applicant related to the District's provision of sewer service to the requesting parcels.

The District has executed two amendments to the Agreement to allow the Applicants additional time to complete the improvements and the dedication process. The First Amendment extended the term of the Agreement to August 1, 2025, and the Second Amendment extended the term to December 31, 2025.

Additional time is needed to fulfill the dedication requirements in the Agreement. The District is working with the applicants to secure the required easements, warranty bonds, lien releases, record drawings, and other miscellaneous items identified in the Agreement.

The District and the Applicants now wish to enter into a Third Amendment to extend the term of the Agreement. This includes an extension of time to complete dedication of the improvements by December 31, 2026.

FISCAL/RESOURCE IMPACTS: There are no fiscal impacts associated with executing the Agreement. The project is privately financed, and the property owners will reimburse the District for all costs associated with the project including preparation of the Agreement, Amendments, plan review and coordination, inspection, and preparation of offer of dedication documents.

**THIRD AMENDMENT TO
SEWER LINE REPLACEMENT
and
DEDICATION AGREEMENT**

This Third Amendment to Sewer Line Replacement and Dedication Agreement (the “Third Amendment”) is entered into effective _____, 2026 (the “Effective Date”) by and between **OLYMPIC VALLEY PUBLIC SERVICE DISTRICT**, a California special district formed, operating, and existing under California Water Code sections 30000 et seq. (hereinafter “District”) and an **UNINCORPORATED ASSOCIATION OF PROPERTIES OWNERS**, consisting of owners of real property located at Assessor’s Parcel Numbers (“APNs”) 096-030-015, 096-030-016, 096-030-017, and 096-030-018 (hereinafter the “Amendment Applicants”) (together, the “Parties”).

RECITALS

This Third Amendment is entered into on the basis of the following facts, understandings, and intentions of the Parties.

- A. The Granite Chief A Line (“A Line”) sewer is an existing private sanitary sewer facility as defined in Section 2.42 of Chapter 2 of the Olympic Valley Public Service District Administrative Code.
- B. On or about July 30, 2024, the owners of real property located at APNs 096-030-016, 096-030-017, and 096-030-018 and District entered into that certain Sewer Line Replacement and Dedication Agreement (the “Agreement”) in which said owners of real property proposed to contract for, commence, and complete construction of the improvements to the A Line and, upon completion thereof to the satisfaction of District, dedicate the improvements, together with any necessary public utility easements and licenses required by District in connection therewith.
- C. On or about October 1, 2024, the Agreement was amended to include the owners of that certain real property located at APN 096-030-015 to the Agreement, to grant an extension of time for completion of certain Agreement conditions, and make other clarifying changes to the Agreement (the “First Amendment”).
- D. On or about August 1, 2025, the Agreement was amended for a second time to extend the term of the Agreement through December 31, 2025 (the “Second Amendment”).
- E. The Parties wish to enter into this Third Amendment to further extend the term of the Agreement.

NOW, THEREFORE, pursuant to the authority vested in District and the Amendment Applicants and in consideration of the mutual covenants and promises of the Parties contained herein, the Parties agree as follows:

AGREEMENT

1. **Recitals.** The Recitals above are true and correct and fully incorporated herein.

2. **Amendment.** Section 2.2 of the Agreement is hereby amended to read:

Term. The Term of this Agreement shall commence upon the Effective Date and shall terminate on December 31, 2026, unless sooner terminated or extended as hereinafter provided. Provided, however, that the District may agree to extend the Term in its reasonable discretion so long as the Applicants perform promptly and expeditiously and are, otherwise, in compliance with the terms and conditions of this Agreement.

3. **Binding Effect and Recording of Memorandum.** The terms, covenants and conditions of the Agreement, as amended by the First Amendment, the Second Amendment, and this Third Amendment shall be binding on and inure to the benefit of the successors, affiliates, transferees and assigns of the Parties.

4. **Miscellaneous.** With exception of the terms, covenants and conditions as expressly set forth herein, the Agreement, the First Amendment, and the Second Amendment shall remain, otherwise, unmodified and in full force and effect. The Agreement, the First Amendment, and the Second Amendment are incorporated herein by reference as if fully set forth herein. All terms not specifically defined herein shall have the meanings set forth in the Agreement.

RESOLUTION 2026-01

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE OLYMPIC VALLEY PUBLIC SERVICE DISTRICT APPROVING AND AUTHORIZING EXECUTION OF THE THIRD AMENDMENT TO THE GRANITE CHIEF "A" LINE SEWER LINE REPLACEMENT AND DEDICATION AGREEMENT

WHEREAS, on July 30, 2024 the Olympic Valley Public Service District, hereinafter referred to as "DISTRICT" entered into an Agreement with an Unincorporated Association of Property Owners, hereinafter referred to as "APPLICANTS," to construct a new sewer main to replace the failing Granite Chief "A" Line; and

WHEREAS, The District has executed two amendments to the Agreement to allow the Applicants additional time to complete the Improvements and the dedication process. The First Amendment extended the term of the Agreement to August 1, 2025, and the Second Amendment extended the term to December 31, 2025.

WHEREAS, additional time is needed to fulfill the dedication requirements in the Agreement; and

WHEREAS, the District and the Applicants now wish to enter into a Third Amendment to extend the term of the Agreement to complete dedication of the Improvements by December 31, 2026; and

WHEREAS, the Board of Directors has reviewed the Third Amendment to the Agreement and considered the recommendations of Staff.

NOW, THEREFORE, BE IT RESOLVED that the Board of Directors of the Olympic Valley Public Service District hereby approves the attached Third Amendment to the Sewer Line Replacement and Dedication Agreement for the Granite Chief "A" Line Sewer Replacement Project between Applicants and District and does hereby direct the Board President to execute said Amendment and such other documents, related thereto or required thereby.
